General Information:

This form is used to open a new account, add a joint owner or open an additional account.

Form Instructions to Open a New Account:

1. Complete all fields in section 1
 - a. Account number – leave blank
 - b. Check New Membership as the reason for completing the card
2. Complete all fields in section 2
 - a. Check the Shares / services in which you would like to open or establish
3. Complete all applicable fields in section 3
 - a. Member information
 - b. Joint owner
4. Print completed form
5. Sign and date
6. Include a copy of your state issued Driver's License for all parties

Form Instructions to Add a Joint Owner:

1. Complete all fields in section 1
 - a. Account number
 - b. Check Other as the reason for completing the card. Type – Add Joint Owner
2. Complete all fields in section 2
 - a. Check the Shares in which you would like to add a joint owner
3. Complete all applicable fields in section 3
 - a. Member information
 - b. Joint owner
4. Print completed form
5. Sign and date
6. Include a copy of your state issued Driver's License for all parties

Form Instructions to Open an Additional Account:

1. Complete all fields in section 1
 - a. Account number
 - b. Check "Other" as the reason for completing the card. And write the reason for completing the card. (Example: Open checking)
2. Complete all fields in section 2
 - a. Check the Shares / services in which you would like to open or establish
3. Complete all applicable fields in section 3
 - a. Member information
 - b. Joint owner
4. Print completed form
5. Sign and date
6. Include a copy of your state issued Driver's License for all parties

All checking accounts are truncated. This means all cancelled checks are not returned with your statement; nor is this an option. Georgia United offers duplicate style checks that provide you with a copy of every check you write. All checking accounts are automatically established with overdraft protection from the Prime Share/Savings, unless specified.

By signing below you make application for membership in Georgia United Credit Union and agree that your accounts with the credit union are and shall be governed by the terms and conditions of the Membership and Account Agreement, Truth in Savings Disclosure, Rate and Fee Schedule, Funds Availability Policy, and Electronic Funds Agreement. In addition, you are bound by all of the credit union's by-laws and amendments thereto which may be adopted from time to time by the credit union. You hereby authorize the credit union to obtain credit reports and investigations as it may deem necessary to establish your accounts and loans. You acknowledge receipt of a copy of the Agreements and Disclosures applicable to the accounts and services requested herein.

Under penalties of perjury, you certify that: (1) The number shown on this form is the correct Social Security Number/Tax ID Number (2) You are not subject to backup withholding (unless indicated below) because (a) you are exempt from backup withholding, or (b) you have not been notified by the IRS that you are subject to backup withholding. (3) I am a U.S. person or U.S. resident alien.

The Internal Revenue Service does not require your consent to any provisions of this document other than the certifications required to avoid backup withholding.
