GEORGIA UNITED BOARD CANDIDATES NOMINATED FOR 2014 BALLOT

Credit Unions are unique financial institutions because our Board of Directors is a member-elected group of volunteers. The board meets monthly to act as member advocates regarding policies and operations within the credit union.

Every year, a nominating committee recommends a slate of members to fill open Board positions. Currently, there are nine Directors and two open positions for three-year terms.



MONSIGNOR STEPHEN T. CHURCHWELL, JCD

Ordained May 1, 1976, and Pastor of Christ Redeemer Catholic Church in Dawsonville, GA through July 2010, Msgr.

Churchwell now serves part-time at the Metropolitan Tribunal of the Archdiocese of Atlanta where he is Adjutant Judicial Vicar. In addition, Msgr. Churchwell was appointed in 2010 to a newly created position of Vicar for Senior Priests where he works with senior and retired priests. Msgr. Churchwell holds a doctoral degree in Ecclesiastical Law, obtained at the Catholic University of America in Washington, DC. He was previously Chairman of the Board of Greater Atlanta Catholic Federal Credit Union prior to its merger with Georgia Federal Credit Union (now Georgia United) in 2004. Since that time, he has served as the Chairman of the Georgia United Catholic Advisory Board and on Georgia United's Board of Directors since 2007.



REPRESENTATIVE THOMAS DICKSON

Former Superintendent of Whitfield County Schools in Dalton, Georgia, Mr. Dickson is currently a member of the Georgia General Assembly serving in the House of

Representatives. A former teacher, principal, and superintendent, Mr. Dickson received his BA degree from Maryville (Tennessee) College, his Masters in Education from the University of Tennessee, and his Ed.S. Degree from West Georgia College. Mr. Dickson is also a graduate of Leadership Dalton sponsored by the Chamber of Commerce. Mr. Dickson has served as a Georgia United director since 1997 and is currently Chairman of the Board.
